

## OFFICIAL Appointments

**PASTOR:** A priest appointed by the Archbishop and delegated as the leader of a particular parish entrusted to him. The pastor's role, expressed in its threefold mission of teaching, governing and sanctifying (CIC, c. 519), empowers the laity for their mission as light and leaven in the world.

**PRIEST ADMINISTRATOR:** A priest appointed by the Archbishop as a temporary leader of a particular parish with the same responsibilities as a pastor (CIC, c. 540 §1-3). This office may be held, for example, by seasoned, newly-arrived priests or by newly-ordained priests who require more experience and formation before being assigned as pastors.

**PASTORAL COORDINATOR:** A deacon, religious or lay ecclesial minister appointed by the Archbishop under the supervision of a priest moderator and entrusted with the day-to-day leadership of a parish (CIC, c. 517 §2).

**PAROCHIAL VICAR:** A priest who renders service in pastoral ministry as a co-worker with the pastor, sharing service in pastoral ministry through common counsel and effort, and under his authority (CIC, c. 545 §1-2).

**SENIOR PRIEST:** A priest who has been granted senior status in writing by the Archbishop and either no longer has a continuous ministry assignment in service to the Archdiocese, or has less than a half-time assignment from the Archbishop.
