## "Walking & Witnessing with Immigrant Families"

What:	The Archdiocese of Seattle is hosting <b>"Walking &amp; Witnessing for Immigrant Families"</b> – a two-week pilgrimage and prayer walk for people to show solidarity with migrants and refugees. The pilgrimage <b>starts on April 29<sup>th</sup></b> and concludes on May 11 <sup>th</sup> with an 11 am outdoor mass at the Northwest Detention Center in Tacoma. During the two weeks, pilgrims will visit more than 30 parishes while they pray for families impacted by immigration around the world.
When:	<b><u>Daily stops</u></b> at 30 + parishes along the routes, including:
	<ul> <li>April 29<sup>th</sup> - Kick-off event at Assumption Church in Bellingham with a commissioning Mass followed by a 3 mile walk to Sacred Heart Church for a viewing of "Dying to Live: A Migrant's Journey."</li> <li>May 5th – Morning start at St. Louise Church with a 4.7 mile walk to the Sisters of Joseph Peace &amp; Spirituality Center in Bellevue for a multilingual prayer service.</li> <li>May 6<sup>th</sup> – Morning start at Christ the King. Catholic school students will join the pilgrimage and host lunch at Gasworks park for 100+ pilgrims. Walk continues on to St. Mary's Church in Seattle.</li> <li>Final Mass on May 11<sup>th</sup> at 11 am at the Northwest Detention Center.</li> </ul>
