

## Are You Interested in Welcoming and Supporting a Ukrainian Individual or Family?

Take the next steps to learn about Welcome Circles\*

	Find 4 friends in or near your community who are 18 years or older to join you in forming your circle
	Identify a financial supporter
	<ul> <li>This sponsor will need to complete the I-134 Declaration of Financial Support AFTER a Ukrainian beneficiary has been identified</li> </ul>
	Identify a Ukrainian individual or family:
	<ul> <li>You may already be connected with a Ukrainian family that you are willing to support</li> </ul>
	<ul> <li>Your local parish/church may know of a Ukrainian family interested in being matched with a sponsor circle</li> </ul>
	<ul> <li>If you have not connected with a beneficiary, then you can apply to be matched via Welcome.US matching portal: <u>Welcome Connect</u></li> </ul>
	To learn about and understand the role and responsibility of Welcome Circles, we recommend that each member of your Circle complete this short course: Welcome Circle Training

## **Ready to Form a Welcome Circle?**

You have identified 5 circle members & a financial sponsor. What next?

<ul> <li>Identify a Ukrainian individual or family beneficiary</li> <li>If you do not have a beneficiary and your local parish or organization has not identified one for your circle, then you can apply to be matched via Welcome Connect</li> <li>You can begin this application while you are completing the Sponsor Circle application (see below).</li> </ul>	
Complete the I-134: When you have a beneficiary match, the financial sponsor must complete the I-134 Declaration of Financial Support found here Form I-134  O Guidelines can be found here: FAQ and Tips for completing I-134	
<ul> <li>Complete the Sponsor Circle application. This link will take you to the Sponsor Circle page that will link you to all the documents mentioned below: Sponsor Circle Application. Please make sure:         <ul> <li>Every circle member completes the required background check.</li> <li>At least one member of your circle completes the sponsor circle course. We recommend that each member completes this helpful and short training.</li> <li>Complete a Welcome Plan, outlining details of how you will receive and support the newcomer(s).</li> <li>Make sure every circle member completes the code of conduct</li> </ul> </li> </ul>	
When your Welcome Plan is complete, your parish/church contact must review it carefully to make sure you are prepared to receive and support newcomers. You may be asked to add/change information in the Plan	
Once reviewed, you can upload your Welcome Plan along with the other required documents and submit.  O When asked to select "Umbrella Organization," please check "USCCB"	
While you wait to be notified about certification and I-134 approval (and your beneficiary match), continue pre-arrival preparation. You might find this helpful: <a href="Pre-Arrival Checklist">Pre-Arrival Checklist</a>
