Ages 16-17: 16-17 BABYSITTER, OFFICE AND ADMIN SUPPORT, COACHING/REFEREE, CUSTODIAL AND YARD WORK, KITCHEN HELP, MUSICIAN, CYO CABIN LEADERS AND SPECIALISTS

Ages 14-15: BABY SITTER, OFFICE AND ADMIN SUPPORT, COACHING/REFEREE, YARD WORK, MUSICIAN, CUSTODIAN AND MAINTENANCE

LICENSING RESTRICTIONS:

It is the business's responsibility to comply with minor work permit requirements. See WAC 296-125-030 and WAC 296-125-033 for Non-Agricultural and WAC 296-131-125 for Agricultural guidelines and restricted activities.

Minors must be at least 16 years old to operate power lawnmowers, nylon string-style weed whackers, or leaf blowers.

Minors working in non-medical settings must receive training to identify the risk of exposure for bloodborne pathogens. Adults must perform any activities with the possibility of exposure to bloodborne pathogens. WAC 296-125-030(24)

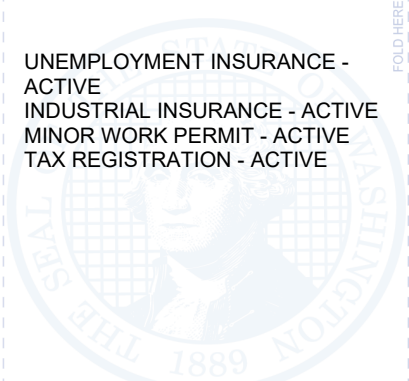
